## **1 Live It Dance Studios Ltd**

1.1 Live It Dance Studios Limited ("Live It ") has a registered office at 40A York Place, Edinburgh, EH1 3HU.

1.2 All joining fees, subscriptions and other receipts shall become the property of Live It. On cancellation or termination of membership no refund will be made to the member of any part of the initial joining fee or monthly membership payments.

1.3 It is a condition of acceptance of membership that the member agrees to pay the initial subscription fee and agrees to be bound by the terms of these rules.

## **2 Payments**

2.1 The annual subscription fee must be paid by the member in full on acceptance by Live It. Fees must be paid by equal instalments at the start of each term payable by cash or direct debit to the Live It's bank from the members bank.

2.2 Live It reserves the right to specify or amend (where reasonably necessary) the method by which monthly membership fees shall be paid e.g. by bankers standing order or direct debit.

## **3 Memberships**

3.1 Live It reserves the right to reject within its reasonable discretion any application for membership of Live It. Applications may be rejected where for example the applicant owes money to Live It, or has behaved in an unacceptable way on the Live It's premises.

3.2 Membership is personal to the member at the location for which membership is granted and cannot be transferred. A member may not loan his/ her membership or permit it to be used by anyone else. Live It may assign the benefit of this agreement to any person, firm or company at any time upon giving at least 30 days prior written notice to the member.

3.3 Live It offers an Individual Membership available to individuals from at least 3 years of age.

## **4 Membership Duration**

4.1 The minimum membership period is 12 months from the membership commencement date shown overleaf.

## **5 Fees**

5.1 The initial subscription fee and the monthly membership fee set out overleaf shall be payable for each class of membership. Live It management shall give at least 30 days written notice of any changes to monthly charges.

## **6 Terminations**

6.1 The membership of any member may be terminated:

a) by Live It:

1. without notice if a member commits a serious or repeated breach of Live It rules as set out in these terms and conditions or as displayed on Live It's notice board from time to time;

2. by notice in writing if any payment owing to Live It by the member remains unpaid 30 days after the due date for payment;

3. Upon not less than 30 days notice in writing if the Live It reasonably suspects that the member is causing undue upset or inconvenience to other Club members or the Live It's staff.

b) By the member:

1. The member may terminate membership by giving at least 30 days prior written notice following the expiry of the initial twelve month period (see above) to Live It. Membership fees will remain payable to the end of the notice period. It will be the member's responsibility to cancel any direct debits concerned.

## **10 Dress**

10.1 Appropriate dress must be worn at all times within Live It premises.

## **12 Conduct of Members**

12.1 Members are expected to behave in an orderly and lawful manner at all times whilst in Live It. Any damage to Club property caused by members negligence or misconduct shall be paid for by the member.

12.2 No alcohol can be brought by members into Live It and smoking is strictly forbidden.

12.4 Members may not enter Live It under the influence of alcohol or mind-altering drugs.

## **13 Disclaimer of Liability**

13.1 Live It Dance Studios Ltd or agents, or employees shall be liable for any loss, damage or theft of personal property belonging to the member or any guest occurring on Live It premises, except where the injury, death, loss, damage or theft is caused by negligence of the Live It, its employees or agents.

13.2 Members and/or guests are advised to undergo a medical examination prior to beginning a physical activity programme. Those with diabetes, heart disease, high or low blood pressure and pregnant women should consult with their doctor to check which dance and/or fitness classes should not be used.

## **14 Other**

14.1 Members must notify in writing to Live It any changes to their name, address or bank details.

14.3 The hours during which Live It is open may change from time to time or for bank holidays, cleaning or decorating. Where possible, at least 14 days prior notice to changes to opening times will be given to members, although shorter or no notice may be given in emergencies.

14.4 Live It management will use its reasonable endeavours to ensure that Live It's facilities are in working order and available for use by members when Live It is open, but there may be occasions when such facilities may either be out of order or not available for reasons beyond the reasonable control of the Live It. A member's entitlement to use of Live It's facilities is therefore limited to those facilities that are available for use at the time they wish to use Live It.

14.6 Any dispute or difference that may arise in regard to the interpretation of these rules shall be dealt with at the discretion of the Live It.

14.7 The Live It reserves the right to vary, revoke or add to these rules from time to time within its reasonable discretion and upon giving 30 days prior notice to members.

14.8 The failure of the Live It or a member to enforce any of its rights at any time for any period shall not be construed as a waiver of such rights.
